The cost of visiting the site shall be at his own expense.



4. The intending Bidders should clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department: The Competent Authority reserves the right to reject any or all the application(s) for purchasing Bid Documents and/or to accept or reject any or all the offer(s) without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tendered at the stage of Bidding.
5. Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating there to and the rules made and order issued there under from time to time.
6. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender and that application will be outright. **13. CRITERIA REGARDING CREDENTIAL POLICY (REF NO-04-A/PW/O/10C-02/14
DATED 18.03.2015 of Principal Secretary to the Govt. of West Bengal, P.W.D.**

- i) Intending tenderers should produce credentials of a similar nature of completed work of the **minimum value of 40% for 1st Call, 30% for 2nd Call & 20% for 3rd Call of the estimated amount put to tender during 5 (five) years** prior to the date of issue of this tender notice; or,
- ii) Intending tenderers should produce credentials of **2 (two) similar nature of completed work, each of the minimum value 30% for 1st Call & 25% for 2nd Call of the estimated amount put to tender during 5 (five) years** prior to the date of issue of this tender notice; or,
- iii) Intending tenderers should produce credentials of **one single running work of similar nature which has been completed of the extent of 80% or more for 1st Call, 75% or more for 2nd Call & 70% or more for 3rd Call and value of which is not less than the desired value at (i) above;**

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency, i.e., the tenderer.

Other terms and conditions of the credentials :-

- i) Payment certificate will not be treated as credential;
- ii) Credential certificate issued by the Executive Engineer or equivalent or competent authority of a State / Central Government, State / Central Government undertaking, Statutory / Autonomous bodies constituted under the Central / State statute, on the executed value of completed / running work will be taken as credential.

No Credentials/ work completion / payment certificate below the rank of Executive Engineer / Deputy Secretary or equivalent will be entertained.

Registered Unemployed Engineers' Co-operative Societies / Registered Labour Co-operative Societies are required to furnish **valid Bye Law, Current Audit Report**, along with other relevant supporting papers. Professional Tax Deposit Challan / **Professional Tax Clearance Certificate for the current financial year, PAN Card, Valid 15 - digit Goods and Service Taxpayer Identification Number (GSTIN) under GST Act, 2017** must be submitted. Payment Certificates in lieu of credentials will not be accepted. [Non statutory documents]

If the dates fall on holidays or on days of bandh or natural calamity, the dates defer to next working days.

- 14. All tenderers are requested to be present during opening of tenders positively.**
15. In case of inadvertent typographical mistake found in the specific price schedule of rates, the same will be treated to be so corrected as to conform with the prevailing relevant schedule of rates and / or technically sanctioned estimate.
16. The intending tenderer is required to quote the rate in figures as well as in words as percentage above / below than or at par with the relevant price schedule of rates.
17. Conditional / incomplete tender will not be entertained.



18. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and he will not be bound to accept either the lowest tender or any of the tenders.
19. Issuance of work order as well as payment will depend on availability of fund and no claim whatsoever will be entertained for delay of Issuance of work order as well as payment, if any. Intending tenderers may consider this criteria quoting their rates.
20. **Statutory deduction by STDS is liable to be deducted as per provision of GST Act, 2017. However no STDS will be made until further order of the Govt. is issued.**
Tax liability of the concerned works contract has to be borne as per prevailing GST Act, 2017 by the agency.
21. A cess of 1% (one percent) will be deducted for contractor's bill on account of the 'Building and other construction workers Welfare Cess Act.1996 (Act 28 of 1996) as per memo. no. 599 A / 4M-28/06 dt.27.09.2006 of the Engineer-in-chief and Ex. officio Secretary, PWD & PW (Roads) deptt.
22. Successful Tenderers will be required to obtain valid Registration Certificate & Labour License from respective Regional Labour Offices where construction work by them are proposed to be carried out as per Clauses u/s 7 of West Bengal Building & other Construction Works' Act, 1996 and u/s 12 of Contract Labour Act.
23. Power of Attorney holders are not allowed to sign Tender Documents unless otherwise approved by Government.
24. Clause-25 of the conditions of contract of the West Bengal Form No. 2911 may be treated to be omitted and there is no provision for arbitration for resolution of disputes that may arise out of the contracts to be entered into by the Department with the contractors for the purpose of carrying out execution of public works as per G.O No. 558/SPW dated 13-12-2011 of P.W.D.
25. Successful tenderer will have to produce all documents in original for verification prior to issuance of Work Order.
26. **Successful tenderers will be required to observe the following conditions strictly:**
- a) Employees' Provident Fund and Miscellaneous Provisions Act, 1952 and Employees State Insurance Act, 1948 should be strictly adhered to wherever such Acts become applicable.
- b) Minimum wages to the workers shall be paid according to the rates notified and/or revised by the State Government from time to time under the Minimum Wages Act, 1948 in respect of scheduled employments, within the specified time as per law. Payment of bonus, wherever applicable, has to be made.
- c) Adequate safety and welfare measures must be provided as per the provisions of the Building and other Construction Workers' (Regulation of Employment & Conditions of Service) Act, 1996 read with West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2004.
- d) All liabilities arising out of engagement of workers are duly met before submission of bills for payment.



27. If there is any violation of any or all the relevant above criteria during execution of the job, it will render the concerned agencies ineligible for the work then and there or at any subsequent stage as may be found convenient.
28. Any intending Bidders who have failed to execute more than one works contract under any Directorate of this Department and was terminated by any sub rule under clause 3 of Tender Form No.2911 or terminated under any clause of Standard Bidding Documents by the Engineer-in-charge / Employer during last 3 (three) years will not be eligible to participate in any bid under any Directorate under this Department for another 2 (two) years from the date of imposition of last termination notice by the Engineer-in-Charge / Employer.
29. Suspension and Debarment of Contractor, Supplier and Consultant participating for Public Works under Public Works Department (Ref. No. 547-W (C)/1M-387/15 dated 16.11.2015 of Joint Secretary to the Government of West Bengal, Public Works Department).
30. **The Agency has to maintained all the protective guideline and Social Distancing Norms for all the working men during execution of works.**
31. **The rate should be quoted by the Agency in BOQ within 2 (two) Decimal, otherwise it should be treated as informal.**

SECTION - A

General guidance for Tendering

Instructions/ Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

1. Registration of Contractor

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to <https://etender.wb.nic.in> (the web portal of public works department). The contractor is to click on the link for e-Tendering site as given on the web portal.

2. Modalities regarding participation of a bidder in different works under PWD & modification of certificate in the declaration proforma attached with the Memorandum No.797-W(C)/1M-24/15 dated 06.12.2017 [Ref. No.80-W (C) / 1 M-24 / 15 dated 25.01.2018 of Additional Chief Secretary, Public Works Department.]

- (a) In a particular N.I.T., having multiple work, a bidder can participate in more than one work provided the bid capacity permits and the bidder is capable to arrange and deploy separate set of required machineries for multiple works and complete the work in specified time.
- (b) In the declaration proforma attached with the Memorandum No.797-W (C)/1M-24/15 dated 06.12.2017, the 5th certificate would be read as "Certified that I have applied in the tender in the capacity of individual / as a partner of a firm" in place of "Certified that I have applied in the tender in the capacity of individual / as a partner of a firm and I have applied to the works under this NIT restricted to maximum one no. works, if more than one work in the same NIT"
